# Connecticut Conservation News for Migratory Birds



During 2019, CT DEEP's Waterfowl and Wetland Programs have been working on a wide variety of projects. They range from collecting data on single species to protecting tidal marshes.

#### Waterfowl Program Highlights

The Waterfowl Program has focused its attention on Canada geese, wood ducks, woodcock, and clapper rails. Canada goose banding is an annual

event. In 2019, Program staff and volunteers, including several from CWA, captured 1,565 geese (931 – New Bands; 634 – Recaptures) at 31 unique sites. To better understand NAP goose migration and harvest, DEEP assisted the U.S. Fish and Wildlife Service and the Canada Wildlife Service with capturing, banding, and nano tagging geese on Prince Edward Island.

Wood duck nest box monitoring continues to be a priority, with staff assessing usage and productivity. CWA has played a major role in annually constructing new boxes to replace those that are in disrepair.

Woodcock populations were assessed by conducting spring singing ground survey routes. Unfortunately, both U.S. Fish and Wildlife Service and state surveys show a gradual, but steady decline in this species. To help combat this decline, the Wildlife Division, is developing a new management plan for Franklin Swamp WMA, which will focus on creating woodcock habitat. The plan calls for several forest clear-cuts, which will be spaced at 5 to 7-year intervals to ensure long-term habitat availability. Work on this project should begin in 2020.

In an effort to gather migratory staging locations and survival information, clapper rails were captured and fitted with nanotags. These devices and strategic placement of monitoring towers allow biologists to track rail travel routes during their annual migration.

Each spring, Wildlife Division staff sample wetland plots across the state to assess CT's annual waterfowl productivity. These surveys provide essential data to make informed waterfowl management decisions.

The Wildlife Division, UConn and volunteers are working on a new CT Bird Atlas Project designed to map all bird species in the state during both the nesting and non-nesting seasons.



CWA recently provided funding for the purchase of a DR mower. This equipment has been used to remove vegetation on dike impoundments at 17 WMAs. This assists with maintaining the integrity of dikes and improves access to impoundment control structures that enhance the ability to manage impoundment water levels.

Wetland Habitat and Mosquito Management (WHAMM) Program Highlights:

Phragmites control continues several areas. Of particular interest is the Lord's Cove WMA and surrounding marsh in Lyme. Over 200 acres of invasive phragmites have had herbicide applied and mowed over the past 3 years by the WHAMM Program and private applicators in conjunction with The Nature Conservancy, U.S. Fish and Wildlife Service, Lyme Land Trust, Gateway Commission, Potopaug Gun Club and several private landowners. This beautiful section of the lower Connecticut River is home to bald eagles, rails, several species of ducks and wading birds, and 5 state-listed plant species. Cooperative efforts to keep the phragmites under control will continue.

## Nehantic Impoundment Project One Year Later

The project entailed installing a water control structure that flooded the area and allowed water levels to be managed to optimize the growth of aquatic vegetation to benefit waterfowl and other water-dependent wildlife. Before the installation, the marsh had this level of water.



In December 2019, the water level has been significantly raised.

**Junior Duck Stamp**

**On October** 24th 2019. the Connecticut Waterfowlers Association (CWA) had an amazing opportunity to work with Art Teachers at the 2019 Connecticut Art Education **Association Conference!** The workshop was entitled: "Art and Conservation - The Junior Duck Stamp Program" and helped educators develop lesson plans that would incorporate both artwork and wetland conservation education associated with the Junior Duck Stamp (JDS) program into their classroom activities. The conference also served as an opportunity to unveil the changes coming to the CT Duck Stamp Program. Beginning in 2021, the CT Duck Stamp will be the winner of the Junior Duck Stamp Contest! Thus, a student in CT will provide the artwork featured on the 2021 State stamp and will also be submitted as the State representative and entrant into the Federal Junior Duck stamp The workshop provided a great contest!

opportunity for the CWA to work directly with teachers and educational leaders from throughout the State to explain the history of the contest and, hopefully, greatly increase the number of schools that participate.

Attendees began the day with the history behind the creation of the first Federal Duck Stamp (with the artwork of Jay "Ding" Darling) which was required by all waterfowl hunters as a means of generating funding towards conservation. Moving on, the presentation showed how the annual process evolved from "hand-picked" artists to become a national contest where individuals from around the country could their artwork for consideration. submit Eventually, the individual states began to take interest and eventually also created their own stamps as well as a "Junior" stamp program, to get students and future generations interested and involved with conservation (while generating funds in state)!

From the classroom perspective, teachers are required to follow specific state or federal guidelines known as "content standards" which are implemented into the daily lesson plans. Attendees provided great feedback as to how the classroom concepts of: landscape, shape. structure/form, and medium can all serve as a means of incorporating and promoting the JDS program at their schools. More importantly the Junior Duck Stamp program presentation opened doors into how schools can create interdisciplinary opportunities where the Art classrooms can work with Biology classes (Ecology, life cycles, etc.), Career and Technology Education classes (Wood duck Box Building), Writing, and Business classes (Funding saved for

Conservation) to look at how the Junior Duck Stamp program can benefit students from a variety of different perspectives.

Fundamentally the workshop provided a phenomenal way for the CWA to illustrate that the goal of the CT duck stamp program is to educate students about waterfowl and wetlands. ultimately resulting in increased support and funding for conservation in CT! What better way to foster this idea than to have a CT STUDENT serve as the 2021 ambassador for the featured artwork! All in all, the workshop helped get the ball rolling on spreading the word and bringing in new schools into the CT Junior Duck Stamp contest. Even if students are not submitting artwork for this year's contest it was great to work with teachers to open the door for communication and provide the understanding that the revenue generated from the sale of the CT stamp provides funding so that the future generations (our current students) can have the opportunity to experience the outdoors as we do today! Even though hunters are the largest contributors to the revenue (due the required purchase for waterfowl hunting), ANYONE can help the cause by buying a stamp! This includes: local bird watchers, conservation minded individuals, hikers, bikers, non-hunting collectors of waterfowl stamps and prints, and even teachers!
