President's Message

On January 20, 2018, Connecticut's waterfowl hunting community lost two of its members in a tragic boating accident. Joseph Formica Jr., 33 of East Haddam and Joseph Grzelak 31, of Griswold both died. Justin Besade, 29, of Uncasville survived.

There was a small craft warning that day for the coast, and although the wind was mild early, it came up to a sustained 20-30 by late morning. This sad event serves as a reminder of the caution that all waterfowlers need to take while participating in our passion using boats. The Connecticut Migratory Bird Hunting Guide had a new section this year stressing steps to take while hunting on the water. It was excellent. However, I would add that all cold weather hunters should have a rescue bag in their boats that includes, at least: towels, clothing, fire starting materials and space blankets. And, obviously, PFD's should be worn at all times while on the water.

The risk of hypothermia cannot be overstated. Several years ago, a young friend called me early in the morning saying "I need your help! I fell in setting decoys. Can you meet me at the boat launch and bring me towels and clothes?" I said "I'll be right there." He only had to go about ½ mile in the boat. By the time I got to the launch, he had made it there safely, and was in his truck drying out. I noticed his boat on the ramp, the engine still down and getting scraped by movement from waves. My friend said, "When I got to the launch, I was delirious and did not have the strength to lift the engine." He was clearly in

the early stages of hypothermia. This from a big strong young man in his early twenties. He fell in 2 feet of water and was never completely immersed, he just got wet underneath his waders! It was cold (in the twenties, but not extreme). The point is, we all need to be extremely cautious hunting in cold weather!

Donations can be made in memory of the hunters. For Joe Formica, an account has been set up for his son Giovanni, at Charter Oak Federal Credit Union, 1055 Hartford Turnpike, Waterford, CT 06385. Joe Grzelak's family asked that memorial donations be made to either Boy Scout Troop 20 of Jewett City, CT 06351 or to the Griswold Booster Club, 267 Slater Ave., Griswoldville, CT 06109. The CWA has made substantial donations in memory of both Joes.

Connecticut Conservation News

The DEEP's Wildlife Division (WD) is moving closer to implementing replacing culverts in the dikes at Barn Island Wildlife Management Area (WMA) in Stonington. This project is funded by a

federal North American Wetlands Conservation Act grant. Hopefully, work will begin this summer to replace the old undersized culverts with new larger ones. This will enhance tidal flow and improve the health of the marshes behind the dikes. The additional flow of salt water will also help provide natural control of Phragmites, as the reed cannot tolerate high salinity.

The WD is seeking to hire additional staff including a 3-year appointment of a Wetland Biologist who would work on the many state-owned inland impoundments and assist with wetland permit work and GIS work. This position would be funded 1/3 through state Duck Stamp funds and 2/3's by federal Pittman-Robertson funds. The WD is also creating a 5-year contract with Ducks Unlimited to accomplish a variety of wetland conservation projects. This would be funded by state Duck Stamp funds.

These efforts represent wise use of Duck Stamp funding. Also, encumbering these monies now could avoid a future "sweep" of those funds by the Legislature, as has happened previously.

Also, these efforts will help offset the Wildlife Division's WHAMM (Wetlands Habitat and Mosquito Management) Program loss of personnel. WHAMM has gone from seven fultime employees to three in recent years! Yet, the Program keeps moving ahead. They were part of a group of Conservation partners that recently completed the first year of treatment of Phragmites in Lord's Cove WMA in Lyme. Typically, when an area is treated for Phragmites control, the first year gets most of it, but follow-up treatment of small patches is usually required

for the following two years. WHAMM also completed several small Phragmites control projects throughout the state. This coming year they will be working on a project to clear clogged channels at Haddam Meadows State Park in Haddam to facilitate the northern pike breeding program. This area is also of great value to waterfowl.

An ambitious effort involving the WD and several **Conservation Partners, "The CT Bird Atlas** Project" will kick off this spring. This Project will both document the distribution of breeding, wintering, and migrating birds across the state and provide population estimates for most species. The last Atlas effort goes all the way back to the mid-1980s, so this project is long overdue. Of interest to waterfowlers, is that this project will identify the status of some of the rare duck breeders in Connecticut, such as blue-winged teal, green-winged teal and gadwall. DEEP will present proposed regulations and take all public comments. Final hunting season dates will be formulated shortly after the comments are compiled and evaluated. Hunters are reminded that DEEP accepts comments on the migratory bird hunting regulations year round; however, this meeting serves to finalize the regulations and is held immediately after the federal frameworks are set by the U.S. Fish and Wildlife Service.


Decoy carvers: Please take advantage of the new "Carvers" page on the Website. Visit there for details. Artists are welcome also.





